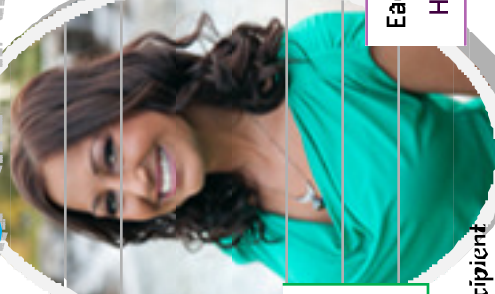
Only 35% of Kentuckians are registered donors. (55% of Indiana & Ohio residents are registered.)
